Opening Round

When you tell friends and neighbors that you are running for election, what do they tell you is the number one issue or problem that needs to be addressed, and what do you tell them about how you will address it?

Target Round

Select Board

Town Meeting and Town Vote recently voted to advance three significant capital projects (WPS, Tri County, DPW). One of these projects, the Tri-County renovation funding will be on the April 1 ballot. What do you think should be the strategy to fund these projects, and how do you communicate to the taxpayers that this is necessary?

Last November Town Meeting voters seemed to indicate that they wouldn't want the Select Board to appoint the BOA and BOH etc, and wouldn't trust the Town Manager, a person appointed by the Select Board, to appoint the Town Clerk because they don't trust the Select Board to do this. How do you respond to this? Should the Select Board as the executive board of the Town be able to appropriately accomplish this?

Planning Board

A significant challenge that the Planning Board will be focusing on this year is the MBTA Communities Act Bylaw. What do you see as the major challenges for the Planning Board and Wrentham in the effort to comply with this bylaw?

How do you see the boards role as a shaping mechanism for future zoning, particularly as it pertains to the Master Plan? Are there particular recommendations within the Master Plan you would most like to see accomplished?

Board of Assessors

Last year's Charter Review Committee recommended making the Assessors office a division of the Finance Department. Do you think this would make the Town's financial management more cohesive, and what do you see as the impact to the Board of Assessors?

Board of Health

What do you think are the most significant lessons learned for the Town and the Board of Health from the COVID-19 pandemic? How do you see to best address those lessons?

Moderator

Last November's Town Meeting had 432 voters attend, which is easily the most attended Town Meeting in the last 10 years. Over that span, the average attendance at

the June Town Meeting is 116 and the average at the Fall Town Meeting is 190. This question is not to imply that it's the Moderator's responsibility to improve attendance. But what are your thoughts on the level of attendance at Town Meeting?

Wrentham School Committee

What role do you see the school committee playing in helping the public understand the effort for a new renovation, especially regarding voters who don't have children in the school? What role do you play in developing funding strategies?

KP School Committee

As a regional school district, there is a challenge of coordinating and coalescing the priorities and assessment for three towns. Do you see your challenge as one more related to balancing the budget, or to curriculum and programs – or even something else?

As a school committee member, what do you think is your role to get input from teachers?

There is a long time trend for parents to be very actively engaged with their children's school at the elementary level, but very much less so at the high school level. Do you see the same trend at KP and is that a concern or a challenge?

Library Board of Trustees

At the national level, surveys are showing a declining use of local public libraries. One such report by the Survey Center on American Life states that almost 60% of Americans say the seldom or never visit their local public library. Are you seeing that trend here, and what ideas do you have to reinvigorate the role of the library in our community?

Housing Authority

Many people have little knowledge of the role and impact of the Housing Authority. I think it is fair to say that of all our elected positions, this is the one where the most voters have the least knowledge of the roles and responsibilities. Does that negatively affect your mission, and if so, what can be done to overcome that?

Wrap Up

If elected or re-elected, what does success look like at the end of the term?

Select Board
